Who/What is ARIZONA@WORK Maricopa County Youth Workforce Services?

Youth Workforce Services is funded by the Workforce Innovation & Opportunity Act (WIOA) and is designed to assist youth 14 to 24 years old with achieving their educational and employment goals.

Eligible youth will work with a Youth Career Advisor (CA/Case Manager) to create a personalized plan for a successful future in education or employment.

- Must be between the ages of 14-21 **AND**
- Be considered low income (Ex. Receiving SNAP, or free/reduced lunch, live in a high poverty area) **AND**

- Are you homeless?
- Are you currently in foster care, or have aged out of foster care?
- Do you have any children or are you pregnant?
- Do you have a disability?
- Are you an English language learner?

• Must be between the ages of 16-24 **AND**

Answer Yes to one of the following:

- Did you drop out of high school and have not been able to get your GED or diploma?
- Have you ever been arrest or in jail?
- Are you homeless?
- Are you currently in foster care, or have aged out of foster care?
- Do you have any children or are you pregnant?
- Do you have a disability?

Eligibility Documents

- Photo ID that includes DOB
- Social Security Card
- Evidence of at least one of the barriers listed
- Selective Service Registration for males 18 and older
